Your clear understanding of our Patient Financial Policy is important to our professional relationship. Please understand that payment for services is a part of that relationship.

## Insurance:

- All copays and past due balances are expected at the time of service.
- Claims will be filed as a courtesy to all insurance plans. If we are not contracted with your insurance, you will be expected to pay at time of service.
- Proof of CURRENT insurance coverage is required in order to file your claims within the timely filing limit. If proof is not provided or confirmed, charges will become your responsibility.
- OB patients will be responsible for any coinsurance, deductibles and copays by their 20th week of pregnancy.
- Late transfer OB patients will be expected to pay by their 24th week of pregnancy.

## Self Pay:

- The classification of Self Pay includes patients who do not have active insurance coverage or patients who have insurance that our practice does not participate with.
  - Refer to our website (<u>www.kmobgyn.com</u>) to review a current list of participating insurance plans.
- Payment is expected at the time of service. A 20% discount will be applied to office visits only.
- Exception Self Pay Pregnant patients must adhere to the following payment plan:
  - o Pay \$4400.00 for routine prenatal care to include a Vaginal Delivery by the 20th week of pregnancy
  - Pay \$4800.00 for routine prenatal care to include a Cesarean Section Delivery by the 20th week of pregnancy
  - A 20% discount will be applied if the balance is paid in full within 45 days of the New OB Interview and Physical visit.
  - Other arrangements should be discussed with the billing department for extenuating circumstances. (ie: transfers, relocations, insurance changes)

## **Bloodwork and Pathology:**

 All bloodwork, pap smears, cultures and other specimens will be sent to Wake Medical Laboratory Consultants for processing. Wake Medical Laboratory Consultants bills for their services. Contact Wake Medical Laboratory Consultants for any questions regarding bills received from Wake Medical Laboratory Consultants.

## **In-Office and Hospital Procedures:**

- Benefits are verified for all hospital procedures and extensive in-office procedures. You will be notified of your financial responsibilities in advance and payment is expected before your procedure is performed.
- A \$100 fee will be charged if you no-show your procedure without a 24hr notice. This fee must be paid before you will be allowed to reschedule your procedure.

**NOTICE TO ALL PATIENTS:** During your scheduled visit, if you have multiple concerns to discuss, your provider may be able to address these concerns today, but...PLEASE BE AWARE that there may be additional co-pays, increased deductible amounts, increased co-insurance amounts or increase self-pay amounts due from you. Insurance companies don't always pay for multiple diagnoses or multiple medical reasons during the same office visit. Please discuss with your provider if you have any questions about your visit.
